Fund Description

Dynamic Allocation - The C-QUADRAT GreenStars ESG pursues an active investment policy and is not restricted by a benchmark. The equity exposure may be up to 100% of the fund's assets and is adjusted to the respective market environment. Moreover corporate bonds can also be added to the portfolio. Derivative instruments may be used as part of the investment strategy and for hedging purposes.

Quality & Sustainability - Regarding the issuer selection, the fund management pays particular attention to the characteristics of quality and sustainability, i.e. it seeks to invest in high-quality issuers that also meet certain environment, social and corporate governance minimum standards.

The Investment Fund is classified as an investment fund under Article 8 of Regulation (EU) 2019/2088 on sustainability-related disclosure requirements in the financial services sector.

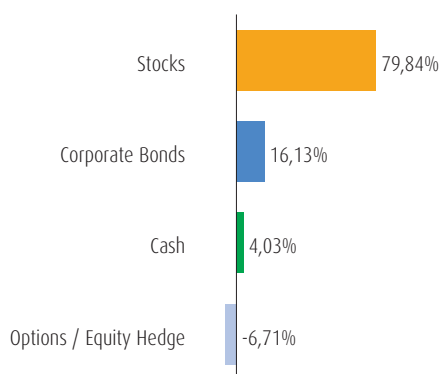
